The two companies will continue to be led by their existing board members and managing directors. WCA Walldorf Consulting's former board members, Hanno Hofmann and Simon Flick, will become shareholders in TIMETOACT GROUP. The parties agreed not to disclose the details of the transaction.

By combining process consulting, multi-award-winning methodological expertise and technical solution capabilities, it has become one of the leading SAP S/4HANA public cloud consultants in Germany. WCA also has in-depth expertise in SAP lease administration in line with International Financial Reporting Standards (IFRS). The acquisition of WCA Walldorf Consulting and target Software Solution is TIMETOACT GROUP's fourth acquisition since funds advised by Equistone Partners Europe acquired a majority stake in the business in June 2021.
